Intellectual Property

Intellectual property rights exist to protect inventions and literary and artistic creations. Countries usually have institutions dedicated to issuing certificates guaranteeing the proprietary rights of inventors, artists and writers. In addition, these institutions preserve, classify, and disseminate information regarding intellectual property, thus facilitating the promotion of industrial and technological advancements, as well as literary and artistic productions. There are four types of intellectual property, and they include: Patents, Trademarks, Copy Rights and Trade Secrets.
